ACTION REQUESTED: Consider reappointments or NEW appointments to the following County Boards, Committee's and Commissions: Airport Advisory Committee; Behavioral Health and Recovery Advisory Board; Developmental Disabilities Advisory Committee; Fair Board; Kittitas County Homelessness & Affordable Housing Committee and the TV Dist. Board.

BACKGROUND: Currently the County has multiple vacancies on its volunteer Boards, Committee's and Commissions. Staff advertised in June of 2017 & September 2017 for upcoming and current vacancies.

INTERACTION: Staff published notice of vacancies through the County's Press Release application which sends notice to the Daily Record, the County website and its subscribers as well as KXLE Radio.
